CERTIFICATE OF AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF CONDOMINIUM LE CHATEAU, A CONDOMINIUM

THIS CERTIFICATE OF AMENDMENT is executed this day of February 2023, Support the Chateau Association, Inc., a Florida not-for-profit corporation ("Association").

RECITALS

WHEREAS, the Association has been established for the operation of Le Chateau, A Condominium in accordance with the Amended and Restated Declaration of Condominium Le Chateau, A Condominium recorded August 22, 2012 in Official Records Instrument # 2012108308 of the Public Records of Sarasota County, Florida, as amended from time to time ("Declaration");

WHEREAS, Article 10 of the Declaration provides that the Declaration may be amended by the affirmative vote of the members of not less than fifty-one percent (51%) of the Units in the Condominium;

WHEREAS, the Annual Meeting was held on January 31, 2023, which meeting was duly noticed, and a quorum was present in accordance with Section (d) of Article 2 of the Amended and Restated Bylaws of Le Chateau Association, Inc. ("Bylaws"); and,

WHEREAS, the amendments were approved by the requisite number of members in the Association in order to meet the Declaration approval threshold.

NOW THEREFORE, the Association does hereby state as follows:

- 1. The foregoing recitals are true and correct and are incorporated herein by reference.
- New language is indicated by <u>underlined type</u>.
 Deleted language is indicated by struck through type.
- 3. 1. Section C(6) of Article 6 of the Declaration shall be amended as follows:
 - C. COMMON ELEMENTS. The common elements include the land and all other parts of the Condominium not within the units, unless otherwise provided herein.
 - 6. Lobby and Detached Guest-Apartment. The lobby, hallways, elevators, and the detached guest-apartment are common elements. The detached guest apartment, identified inon the Plat as the Gate House, may be used as living quarters for an is intended for residential use by an onsite Association-manager, or OR as an amenity for if not occupied by an onsite manager, may be reserved for the exclusive use by Unit Owners, their family and friends, as the case may betenants, guests and invitees on a first come first served basis. The use of the guest-apartment shall be overseen

by the Board of Directors in accordance with rules and regulations adopted by the Board governing the use of the guest-apartment. A fee may be charged in connection with the exclusive use of the guest apartment.

2. Section C of Article 14 of the Declaration shall be amended as follows:

C. PETS. No pets are permitted in any Condominium unit or anywhere on the Condominium property, except that one cat or one dog not over fifteen (15) pounds in weight may be kept by the onsite manager, if the detached Aspartment is occupied as the onsite manager's residence, and the cat/dog may be carried on and off the Condominium property to and from that residence.

All other Sections remain unchanged.
